- This Utsunomiya City Priority Benefit Payment is a new grant to support households only with Per Capita Basis Residence Tax that are affected by rising energy, food prices.
- To receive the benefits, procedures are required.

Amount of Benefits

When Benefits Come

100,000 yen per household

※Head of household will receive it.

It is about 3 weeks after Utsunomiya City receives confirmation form.

XIt may take more than 3 weeks in some cases.

Eligibility and Proceeding

Eligible Households

(Households with residence registration in Utsunomiya City as of December 1, 2023)

Household whose all members are only "on Per Capita Basis Residence Tax in FY 2023"

Household whose members are

"on Per Capita Basis and Exempt from Residence Tax in FY 2023"

**Households with only dependent(s) of a person subject to Per Capita Basis Residence Tax are NOT eligible.

Notice: Households whose members are all Exempt from Residence Tax are NOT eligible.

The city starts to send the form from Friday, March 29.

(You need to fill in and send it back.)

Application Deadline: Friday, June 28, 2024

Application Procedures

- Heads of eligible households will receive a confirmation letter from Utsunomiya
 City, which includes info on the benefits and entries to be confirmed.
- Fill in the form and <u>send it back by post</u> in the return envelope with necessary documents.

Check the following:

- 1) There is no mistakes in the bank account information to receive the benefits.
- 2 Household does not consist of only dependent(s) of a person subject to Per Capita Basis Residence Tax.
- 3 You have not received this grant of 100,000 yen from Utsunomiya City or other municipalities yet.

What is "only on Per Capita Basis Residence Tax"

Personal residence tax is the sum of two taxes: "per capita" and "per income."

"Per capita basis" is taxed equally on those whose income exceeds the tax-exempt limit, regardless of your previous year's income. "Per income tax" is calculated and placed according to your income in the previous year.

"Only on per capita basis residence tax" means that "per capita basis" is taxed and "per income tax" is not.
